

If you are a *Metro Access* Customer.....

1. You can use the **Metro Access Paratransit Buses**. Cost, per one way trip, is two times the fastest comparable fixed-route fare, with a maximum fare of \$6.50.

2. You can use both **Ride-On, Metro Bus AND Subway/Rail** for free. You will need to have you Metro Access ID Card on you when entering the bus (or the subway terminal), and swipe your Metro Access card when entering the bus or subway terminal. Smart Trip Phone Number: if you have a Metro Access ID Card, you do not need to obtain and present a Smart Trip Card).

3. You can use **Abilities Rides**. If you live in Montgomery County, you need to call 301 990 9100 in order to schedule a ride with Abilities Rides/Regency Cab. You can take up to 4 rides a day. Rides need to begin OR end in Montgomery County. You pay the first \$5. Metro/WMATA pays the next \$15. You are responsible for any amount over \$20.

4. If you live in Montgomery County AND are not a Call N Ride customer, then you can use Montgomery County Government's **Call N Ride/Same Day Access Program**. Participant can put \$30 on Call N Ride/SDA Account per month, and receive a \$60 value per month.
